**BRAINHUNTER SIGNS OVER \$26.5 MILLION OF  
FEDERAL GOVERNMENT CONTRACTS**

**Federal Government Backlog Exceeds \$50 Million**

**Toronto, Ontario**, April 29, 2009 – Brainhunter Inc. The contracts cross more than 20 departments and include both renewals of existing business and new contracts.
